She shared more information about Skyline's involvement in this process which includes a ZTC English AA pathway. ZTC is currently located in CTTL with support of the library. The request is that Academic Senate engage in further discussion regarding setting up ZTC as a standing committee with AS. And be housed in the office of instruction under the VPI

- sympathy towards the union and how unions work as well as a desire to be involved in contract issues.
- transparency
- courageous
- red flags: seeing this as a stepping stone to something larger, no community college background, if they don't mention students, equity or anti-racism without specifically being prompted, do they want A job vs THIS job, lots of buzz words.
- more black faculty and support for black students
- a commitment to support and promote black faculty in order to keep them
- experience with online education
- recent teaching experience
- proven track record for equity work that includes engagement rather than just rhetoric
- experience working in higher education
