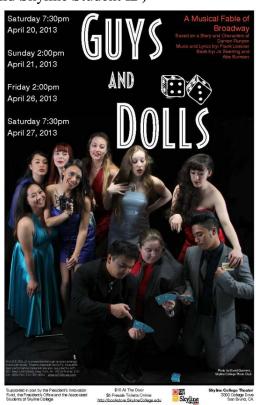

# **ASTEP Scholarship Created**

To honor the passing of his mother, Helga Burnham Watson, SparkPoint Director William Watson, and his husband, James Ball, have created a memorial scholarship. The \$1,000.00 scholarship will be awarded annually to an ASTEP student with a minimum 3.0 GPA who has a demonstrated commitment to social justice and equity, with plans to transfer to a baccalaureate degree granting institution.

Helga Burnham Watson (1922-2013) was a community organizer for voter registration drives in 1960s rural Mississippi. Despite multiple threats to her safety by members of the Ku Klux Klan and John Birch Society, she ran for public office to promote voter participation among African Americans. She was an active member of the NAACP, the Scott County Improvement Association, and the Scott County Democratic Coordinating Committee where she worked to incorporate the gains of the Mississippi Freedom Democratic Party into a more inclusive Democratic Party in Mississippi

### **Accreditation Update**

The 3rd Accreditation Open Forum held on April 23, 2013 was a success. Skyline College students, faculty, staff and administration enjoyed lunch, provided comments and offered suggestions for the final Accreditation Self Evaluation Report. We reviewed the accreditation timeline of where we are and where we are going. Thanks to Dean Ray Hernandez for leading a discussion on the Delineation of the Functions Map which is intended to illustrate how the three colleges and the district manage the distribution of responsibility by function. A special thanks to Vice President of Instruction Sarah Perkins for leading a lengthy discussion about The Rubric for Evaluating Institutional Effectiveness. The Rubric for Evaluating Institutional Effectiveness was developed to assist colleges as they conduct their Self-evaluation and it also helps in assisting external review teams as they examine institutional quality during accreditation reviews. The Rubric gives institutional members, evaluators, and the Commission a common language to use in describing the institution's practices in three key areas of the continuous quality improvement process: Program Review, Integrated Planning and Student Learning Outcomes.

Many suggestions were received and will be included in the Self-evaluation as examples from participants which demonstrate continuous quality improvement at the college. For example, the English faculty used results from the SLOAC process to make changes to their programs. This example and many others will be incorporated into the final accreditation Self-evaluation.

Thank you to everyone who attended and participated in the dialogue. Special kudos to the students for their contributions. We look forward to showing the Accreditation Committee how Skyline College really does Shine.

#### **Approval of March 27, 2013 Minutes**

(M/S/U) Blake/Sanchez Sosa. The CGC approved the March 27, 2013 minutes.

#### **Classified Council Report**

Barbara Daley, Vice President of Classified Council, reported to CGC on behalf of Linda Allen who is currently on vacation this week. She announced that Classified Council cannot support the merging of IPC and CBC yet because they need more information regarding the makeup of the new committee, how many Classified Staff would be members and how would it affect their workload as members of the new committee. The Classified Council could not make a recommendation at this time until they have more information.

At the last Classified Council meeting Linda Allen discussed the Novi Survey, the IPC Research Form and the Educational Master Plan. She encouraged all Classified Staff to visit the PRIE website.

Heather Smith from the SparkPoint Center gave a presentation on BACC and CLASP partnership. The Classified Council held a One-Hour Classified Staff Mini-Retreat on Friday, April 12. The topic was Juggling Act: Overview of Work/Life Balance and it was facilitated by Claremont EAP. The topic was chosen based on a survey of Classified Staff.

Barbara mentioned to the College Governance Council a concern with regards to the Second Harvest Food Bank bins that are located throughout the campus. Nancy Lam asked Classified Council who is responsible because there are some bins that are full. The topic will be presented to the Managers at the next Managers Council.

This June there will be a 3-day Classified Leadership Institute being offered by State Classified Senate in Sacramento, June 13-15, 2013. Classified Staff is encouraged to attend.

The next Classified Council meeting will be a Potluck, Thursday, May 2<sup>nd</sup>. The Classified Council plans to have a presentation by Donna Bestock and Christine Roumbanis who will give an update of the Accreditation Draft; a discussion of the election of new Executive Board members for 2013-2014; organizing a Summer Retreat; and continuing to work on the revisions to the Classified Council by laws to work toward becoming a Classified Senate.

It was suggested by Dr. Sarah Perkins to ensure that the Classified Council website reflects the work of becoming a Classified Senate.

#### ASSC Report

Jose Sanchez Sosa, President of Associated Student of Skyline College, reported on the successful hAPI Festival held Wednesday, April 17<sup>th</sup> from 11-2:30 in the Quad. Over 1000 people passed through the festival and participated in the event. Also the same week the San Francisco Poet Laureate, Alejandro Murguia and singer songwriter Diana Gameros presented poetry and music Friday, April 19<sup>th</sup>.



#### Academic Senate Report

Leigh Anne Shaw, President of Skyline College Academic Senate, attended the Academic Senate Plenary Session held April 18-20, 2013. Beth Smith of Grossmont College was introduced as the new State Academic Senate President. Leigh Anne worked with Beth on a State Equity Group.

At the Plenary Session Leigh Anne attended a couple of interesting sessions. One was a workshop regarding awards that the State Academic Senate offers each year. There is a problem with getting nominees for the awards. She also attended a workshop "The Scorecard, Disproportionate Impact, and Student Equity".

Currently the Skyline College Academic Senate elections calls for nominees have been sent to all faculty. In preparation for the end of the year festivities a request to faculty for the Meyer award has been sent. Leigh Anne is requesting a list of all full-time faculty hired in the last 5 years in order to choose the Meyer award recipient. Academic Senate is also considering the faculty marshal for Commencement.

The state equity group is talking about integrating the equity plan into existing plans and reports such as BSI, Accreditation and Matriculation Plan. Leigh Anne also would like to examine communication flow of information.

#### **Delineation of Function Map**

(M/S/U) Perkins/Blake. Sarah recommended the Delineation of Function Map as presented.

#### **Accreditation Oversight Committee**

Dr. Sarah Perkins proposed to the College Governance Council the need to add the Accreditation Oversight Committee to the Compendium of Committees. The representation on the committee would be from each constituent group on campus and they would meet once a semester. The group will not be a decision making committee.

A recommendation of the new committee will be made at the next meeting. Each constituent group will discuss the new committee at their next meetings.

#### **Participatory Governance**

(M/S/U) Perkins/Shaw. Move approval to changing the reference to Participatory Governance and have it reflect in the charter and bylaws.

Dr. Regina Stanback Stroud reported to CGC regarding shifting from Shared Governance to Participatory Governance. The word Shared Governance to Participatory Governance has been revised to the bylaws.

#### **Announcements**

## **Governance: College Budget Committee**

The College Budget Committee met on April 25, 2013 with Leigh Anne Shaw and Eloisa Briones as cochairs.

**District Committee on Budget and Finance (DCBF) Report** At its April 16<sup>th</sup> meeting, Executive Vice Chancellor Kathy Blackwood provided an update on the Governor's Budget proposal for 2013-2014. The Legislature did not support most of the proposals. To date,

- The 90-unit cap has been rejected.
- The proposal to shift Adult Education to Community Colleges has been rejected, however the Department of Finance is working on a new one.
- Budget to include \$197 million to provide for 1.65% COLA, 1.4% for access/restoration and \$30m for the Student Success & Support Program (formerly Matriculation) which requires a 3:1 match.
- SB806 has been proposed to include all faculty in the 50% law which means not only instructional but also non-instructional faculty (librarians and counselors).

The announcement of the May Revise is scheduled for May 14. Kathy also shared that property taxes in San Mateo County have increased by 4%. The three colleges will offer more sections to meet the state funded FTES cap.

CBC reviewed the Draft Proposal for New Resource Allocation that is being discussed at DCBF.

A new component/adjustment being considered is a minimum staffing level to operate a college. There was a concern over the language of "minimum staffing" which may not be an accurate assumption for colleges of different size. A lengthy discussion ensued with a recommendation that the factor of college size be primary in developing this model. Assumptions for Instructional Staffing were reviewed as well. Overall, it was shown that Skyline College and Cañada College are less staffed than CSM, and this model appeared to recognize that inequity. Feedback from CBC will be reported to DCBF as discussions on improving the district resource allocation model continue.

#### Merging of IPC and CBC

CBC continued to discuss the idea of merging the Institutional Planning Council (IPC) and the College Budget Committee (CBC), possibly beginning in FY2013-14. At the IPC meeting of April 24, 2013, there was overall support for merging the two committees but needed scenarios to understand how it would work. The goals of merging IPC and CBC as one committee are:

- 1) To integrate financial resource planning with institutional planning;
- 2) To keep IPC and CBC informed of the college's various plans, goals and strategic priorities which are the base foundation for decision-making in the allocation of resources; and
- 3) To systematically assess the effective use of financial resources and use the results of the evaluation as the basis of improvement of the institution (Accreditation Standard III.4)

The committee considered these scenarios:

- 1) Status quo: IPC and CBC remain separate;
- 2) Merge IPC and CBC so that all committee members participate in all aspects of budget and planning;
- 3) IPC becomes the "parent" to CBC, meaning CBC becomes a subcommittee of IPC.

The name of a merged committee would be changed to reflect the integration of both committees. The committee actively engaged in discussing the pros and cons of each scenario.



Merging will strengthen the integration of the planning and budget process as decisions in the allocation of resources will be grounded on institutional plans, goals and strategies. This will also enhance the planning and budgeting cycle to include a regular assessment at the end of each year. A motion was passed and approved to combine the two committees and look at membership to ensure adequate representation: Morello/S: Zamani. While it might be difficult to change this structure for Fall 2013, it could happen. The College Governance Council will make the final decision based on recommendations from IPC and CBC.

Next Meeting: CBC is scheduled to meet on May 9, 2013.

# Skyline College Student Wins First Public Safety Scholarship

Administration of Justice major, Gilbert Arellano, received the first Richard L. Resurreccion Public Safety Scholarship at the Phi Theta Kappa convention on April 5, 2013.

This scholarship is for members of Phi Theta Kappa who demonstrate potential for involvement in public safety or service while enrolled in an associate degree public safety program (e.g. Criminal Justice, Emergency Medical Services). Applicants may be part-time, full-time or international students. Applicants must have a minimum 3.5 GPA on all course work and complete by June at least 50 percent of coursework in an associate degree public safety program at a two-year college. Applicants with previous associate, bachelor's, or master's degrees are eligible.

- Submit your article by 3:00 p.m. on Thursdays; articles received after this time will appear in the following week<sup>1</sup>s issue.
- Place your submission in a Word document with your pictures pasted in the document.
- Use medium sized pictures that are equal to 1/4 or 1/2 of a page. Do not place pictures next to each other, they must be on separate lines.
- Use Times New Roman 12pt. font that is justified to the left for the body of the article.
- Please make sure your article is single spaced.
- Don¹t forget to add a headline/title using 18 pt. bold font that is justified to the center
- Use the following commonly accepted abbreviations: a.m. or p.m. (i.e. <sup>3</sup>The event will be held from 8:00 a.m. 1:30 p.m.<sup>2</sup> <sup>3</sup>The workshop is scheduled to run from 9:30 a.m. Noon.<sup>2</sup>
- Spell out numbers of one or two words. Use figures for numbers that require more than two words to spell out. (i.e., <sup>3</sup>Almost eight years ago I began taking ceramics courses.<sup>2</sup> And <sup>3</sup>I counted 176 records on the shelf.<sup>2</sup>).
- If a sentence begins with a number, spell out the number or rewrite the sentence.
- Use the month, day, a comma and the year to indicate the date (i.e., <sup>3</sup>March 4, 2011<sup>2</sup> not <sup>3</sup>March 4th, 2011 or March 2nd, 2011<sup>2</sup>).
- Add the word College when you refer to the name Skyline (i.e., Skyline College instead of Skyline).
