2.1 Professional Development

2.2 HSI Grant- Nick Langhoff

- Last year applied for HSI stem grant.
- HSI Title 5 grant (deadline early summer) solicitation
- Max amount \$650,000/year for 5 years for individual or collaborative (\$775,000)

2.3 DREAM Center

Chad Thompson- appointed lead administrator

- Soft launch tomorrow, February.1st Space Identified, Room 1219. Dream Center website is live.
- Decision to open as a direct response to current political climate, the need for a safe space for students. Vision to have it be a student-centered space, who will design and take ownership of it.
- Searching for a candidate to fill Admin Assistant/Coordinator position for the center. Estimate have a hired staff within two weeks. A spark point staff member will be at the front desk until a new person is hired.
- Needs for areas of expertise: Financial Aid, admissions, transfer, free legal support (off campus)
- Forward names of interested students to volunteer to Chad Thompson
- Will purchase recording of webinar on February 7, 2017- 11:00AM, "A Trump Presidency 2017: What does this mean for Undocumented Students and their families."
