E. ASSC Budget Update

1. Alex - ASSC has spent around nearly half of its budget. The remaining half of the budget can be put to good use for Spring 2013.

F. Legislative Update Presentation

- 1. AB-19 requires the Secretary of State to initiate program to allow a county to vote via the Internet.
- 2. AB-27/SB-21 appropriates \$15,000,000 to the General Fund for the Regents of the University of California to the School of Medicine at UC Riverside.
- 3. AB-41 would have the Legislature state its intent to enact a bond to provide funding for the construction and modernization of education facilities.
- 4. AB-51 create a program at three CSU institutions partnered with local CCDs and county offices of education to offer bachelor's degrees
- 5. SB-32 directs the CSU Board of Trustees and requests the UC Board of Regents to explore innovative ways to offer a bachelor's degree at a cost of <\$10,000 in systemwide fees and textbooks
- 6. SB-35 would require the CCC BoG and the CSU BoT and request the UC Regents to develop and administer a system-wide Energy Solutions Action Plan that provides strategy concerning energy savings projects.
- 7. SB-44 would require all websites maintained by the state to include a hyperlink on the site's homepage to the online voter registration page of the Secretary of State's website.
- 8. Assembly Constitutional Amendment-2 Education Finance: Payment of State Apportionments would introduce language for a referendum on a constitutional amendment which would eliminate deferral of apportionment-based funding beyond the fiscal year. While this would prevent the accumulation of deferrals, it would result in outright cuts being the only option in the event of revenue shortfall.
- 9. Senate Constitutional Amendment -5 Public Postsecondary Education: Student Recruitment and Selection Allow schools to use race, sex, color, ethnicity, or national origin in admission decisions.
