2.3 Enrollment Strategies Committee "Roadshow"

Notes: The ESC Tri-Chairs were present to share the work the committee has done and present the Enrollment Strategy Plan. Their work was structured by two work groups which included a focus on new students and the other on returning students.

For the new students, the goal set forth by the committee was:

Increase first-time headcount in adult students by 10% over five years starting Fall 2024.

For the continuing students, the goal set forth by the committee was:

Increase continuing and returning student engagement in a support program (ex: EOPS, PSP or TRiO, etc.) by 15% over five years.

The tri-chairs went on to explain implementation of a plan to reach these goals and to integrate these plans with existing work on campus.

Enrollment Strategies Committee Presentation

During the Q&A section, a motion for a 5-minute time extension was made by President Ayotte and was seconded by Senator Lucas. The discussion included suggestions for more county wide marketing including signage. Some specific questions regarding baseline data were raised and the committee said that they would gather that information and share back at a later date.
