### Kenny Gonzalez-

Dear Academic Senate, Several counseling division faculty members have expressed concerns about the recently approved presidential search committee. As it currently stands, only two divisions are represented among the four members: Business and STEM. While we recognize the challenges of including representatives from every division, we believe a more balanced representation would significantly enhance the committee's ability to identify a presidential candidate who can effectively address the multifaceted needs of our faculty, students, and staff.

In the best interest of the college, counseling faculty asks that the Academic Senate to reconsider the composition of the search committee. We propose examining how to expand the committee to include representatives from a wider range of divisions, including student services. This increased diversity would bring to the table a variety of perspectives, experiences, and expertise, fostering more informed discussions and decision-making.

By broadening the representation on the search committee, we can ensure that the committee's deliberations are grounded in a deep understanding of the unique needs and aspirations of our diverse campus community. We believe that a more diversified representation on the presidential search committee will ultimately lead to the selection of a president who is better equipped to navigate the challenges and opportunities facing our institution.

### Alberto Santellan

- Hello members of academic senate. For those who don't know me, my name is Alberto Santellan, a proud counseling faculty member as well as a member who served on academic senate the past 4 years. I come to you today to share my thoughts on the recent vote regarding the president screening committee. Only two divisions from across the college are represented in the faculty make up of the screening committee. Four faculty members from 2 divisions.... from 8 divisions that make up the college. I want to bring to light a discussion that occurred at an academic senate meeting on March 2, 2023. On this day, a discussion took place specific to screening committees rubric/guidelines and within the discussion elements of that discussion included the following- to "seek the most representative committee possible."

This stark underrepresentation of the voted screening committee members goes against the discussion we set for ourselves when we committed to a more inclusive, diverse selection process. The president we are choosing is not just a leader for two divisions-they will be making decisions that affect all divisions, all students, all faculty, and all staff across the entire college. Yet, with such limited representation on the committee, how can we expect to select a president who truly understands and is prepared to meet the needs of everyone? I urge academic senate to revisit this process and ensure that all divisions are fairly represented, so that the president we select can truly serve the entire college.
