President Stanback Stroud Reported the following

- The college received a report back from the company who are working on the zero to no cost text book. Dean Jim Houpis has been asked to be more aggressive to make it available to faculty and encouraging more faculty to sign up for it.
- Dean Jim Houpis and the administration are looking into how to make more full degrees available online. They will connect with faculty to create curriculum.
- Success Summit was held last month. A major conversation at the event was around Workforce Development. The Board of Trustees has asked the colleges to have an infrastructure that makes it possible for students to use the resources to get jobs. The College wants to make it possible for Career Services and Job Placement is connected to the Career Technical Education programs. Redefining the role of Workforce Development and creating a Dean of Workforce Development and Strategic Partnerships. New Classified Staff have been hired as Job Developers that will be part of the new in fracture. Career Services will be a resource to Job Placement.
- The College is developing an Equity Institute that will focus on professional training, development of equity available to the college and organizations. It will be announced at the Equity Summit being held Friday, November 2nd here at Skyline College.
- The Superintendent of Jefferson Union High School District, Dr. Terry Deloria, has asked to work with Skyline College to establish an Early College at Skyline College.
- The Director of Guided Pathways and Comprehensive Redesign has been selected. The candidate, Dr. Michael Reiner, has been forward to the board.
- Skyline College will have a temporary Voting Center on Campus located in building 19. Community members will be on campus to drop off and/or vote for the November election.
- The Human Resources plan will be updated by Vice President Eloisa Briones.
- The SMCCCD Board of Trustees will be acting on the customer relationship management software.
