

STEPS TO APPLYING AND COMPLETING YOUR FINANCIAL AID APPLICATION

STEP 1

SUBMIT AN APPLICATION

- GO TO: www.fafsa.gov (U.S CITIZENS & ELIGIBLE NON-U.S CITIZENS)
- GO TO: www.dream.csac.ca.gov (AB 540 AND UNDOCUMENTED)
- CLICK “START A NEW FAFSA or CA Dream Act”
- LOG IN USING THE **FSA ID/Login Credentials** (SEE BACK ON HOW TO CREATE AN FSA ID)

2021-2022 if attending Fall 2021, Spring and Summer 2022

STEP 2

PROCESSING

AFTER SUBMITTING, ALLOW **1-2 WEEKS** FOR APPLICATION TO BE PROCESSED AND SENT TO THE COLLEGE'S FINANCIAL AID OFFICE. STUDENTS WILL RECEIVE TWO EMAILS: ONE FROM THE DEPARTMENT OF EDUCATION AND ANOTHER FROM THE COLLEGE'S FINANCIAL AID OFFICE CONFIRMING RECEIPT.

- MAKE SURE TO REVIEW THE STUDENT AID REPORT (SAR) ON THE DEPARTMENT OF EDUCATION'S EMAIL FOR ACCURACY. IF ANY CORRECTIONS NEED TO BE MADE, DO SO ON THE FAFSA.GOV WEBSITE AND ALLOW AN **ADDITIONAL 1-2 WEEKS** FOR PROCESSING.

STEP 3

SUBMIT DOCUMENTS

CHECK WEBSMART TO SEE WHAT ADDITIONAL DOCUMENTS ARE REQUIRED:

- GO TO: websmart.smccd.edu —LOG IN USING STUDENT **G NUMBER** AND **PASSWORD**
- CLICK “FINANCIAL AID” TAB
- CLICK “MY ELIGIBILITY”
- CLICK “STUDENT REQUIREMENTS” - **SELECT AID YEAR (FOR EXAMPLE: 2020-2021 or 2021-2022)**
- REVIEW “STUDENT REQUIREMENTS”

SUBMIT ANY DOCUMENTS TO THE FINANCIAL AID OFFICE WITH A VALID PHOTO ID PRESENT.

STEP 4

FILE REVIEW

PLEASE NOTE: FILES ARE REVIEWED IN THE ORDER OF DATE RECEIVED

FILES WILL **NOT** BE REVIEWED UNTIL ALL REQUIRED DOCUMENTS ARE SUBMITTED. THE FINANCIAL AID OFFICE MAY REQUEST ADDITIONAL DOCUMENTS IF NEEDED. THE ENTIRE PROCESS MAY TAKE A MINIMUM 2-3 WEEKS.

ANY NOTIFICATIONS FROM THE FINANCIAL AID OFFICE WILL BE SENT THROUGH THE MY.SMCCD.EDU STUDENT EMAIL.

STEP 5

RESULTS AND FUNDS ARE PAID

CHECK WEBSMART FOR FINANCIAL AID RESULTS AND AWARD INFORMATION AFTER THE APPROPRIATE PROCESSING TIME HAS PASSED OR CONTACT THE FINANCIAL AID OFFICE.

OFFICE POLICY – VALID PHOTO IDENTIFICATION

STUDENTS MUST PRESENT/ENCLOSE A VALID PICTURE I.D. WHEN ASKING QUESTIONS AND SUBMITTING DOCUMENTATION TO THE FINANCIAL AID OFFICE.

SATISFACTORY ACADEMIC PROGRESS (SAP)

TO CONTINUE RECEIVING FINANCIAL AID, STUDENTS MUST MAINTAIN A **CUMULATIVE PACE RATE OF 67% AND A CUMULATIVE GPA OF 2.0**. IF SAP IS NOT MET, STUDENTS MAY APPEAL THEIR FINANCIAL AID BY COMPLETING THE FOLLOWING STEPS:

- COMPLETE THE APPEAL FORM
- SCHEDULE AN APPOINTMENT TO MEET WITH A COUNSELOR AND UPDATE STUDENT EDUCATION PLAN
- COMPLETE AN ONLINE SAP COUNSELING SESSION

FEDERAL PELL GRANT LIFETIME ELIGIBILITY USED (LEU)

Effective July 1, 2012 students can only receive a lifetime maximum of up to 6 years or 600% of Federal Pell Grant regardless of when they received their first Pell Grant.
