2. GENERAL FUNCTIONS

2.1. Call to Order

3. ACTION ITEM(S)

3.1. Approve Agenda

4. DISCUSSION/REPORT

4.1. Resource Allocation Task Force Update:

Committee Tri-chair Joe Morello provided a brief update on the Resource Allocation Task Force. The current resource allocation model is to stay in place for FY23-24.



4.2. Vote on sending final EMP draft to CGC for approval:

A motion to recommend the 2023-2028 Skyline College Education Master Plan to College Governance Council for approval was made by Tina Watts and seconded by Karen Wong. The motion passed unanimously.

4.3. Instruction ALUR Presentation:

Dr. Vinicio Lopez joined SPARC to present the Administrative Leadership Unit Review (ALUR) for the VP of Instruction office. The presentation included a summary of the eight divisions under the VPI office and program resource requests under those divisions. Dr. Lopez highlighted accomplishments as well as challenges in the Instructional divisions. Some key highlights included a thorough dive into the Strategic Partnerships and Workforce Development division to see what has been working successfully and where improvements are needed, an upcoming Culturally Responsive Pedagogy Grant, and a potential Office of Instruction Newsletter.
