SPARC M-V-V UPDATE - COLLEGE-WIDE M-V-V FEEDBACK SURVEY HIGHLIGHTS

October 31, 2024

BACKGROUND

Below is an an aggregation of the highlights of feedback gathered through the college-wide M-V-V feedback survey which closed on October 24, 2024. This survey was conducted to support SPARC in finalizing and voting on recommending the forthcoming updated M-V-V for adoption by College Governance Council (CGC).

An excel doc export of the M-V-V feedback survey results were shared with SPARC Committee members separately via e-mail ahead of the October 31, 2024 SPARC meeting (for which the review of the survey results below is agendized for discussion).

Note: all feedback items below were open for discussion at October 31st SPARC meeting, regardless of value in "status" column. Post-meeting next steps noted in status columns, where needed. PRIE will be bringing an updated draft including changes below incorporated to November 11, 2024 for voting consideration.

I think the sustainability statement needs to be more urgent, active, and inclusive. Almost every other value statement is very specific about pointing out areas we will work on, but this one pretty much just says we will try to get people to act "sustainably" and the generic dictionary catchall people say about "meeting the needs of the present without compromising the needs of the future" that doesn't really do much to guide our actions. I would prefer something more thoughtful and guiding -- i.e. "We are committed to fostering an institutional culture of environmental justice and sustainability among all members of our college community through education, demonstration, and engagement that will go with them off campus and make an impact in the world. We will inform and encourage our communities toward best practices in waste reduction, energy savings, and sustainable innovations and work to make our college functions as low-waste and high-intention as possible, normalizing sustainable behaviors in our community." It doesn't have to be exactly that, but my point is that other statements have more ideas and detail, and this one currently does not, so it's much harder to act on.
