- Provides social and academic support for men of color in SMCCCD, specifically Skyline College students, through individual, group, and peer mentoring, as well as leadership development opportunities.
- The program welcomes all students but is focused on supporting men of color.
- Student Participation Goals:
  - Building Brotherhood: Foster community and belonging through “Slide Thru” sessions.
  - Leadership & Empowerment: Develop leadership potential to achieve educational, career, personal, and financial goals.
  - Mentorship: Build intentional relationships with peers, staff, faculty, and professionals in SMCCD.
  - Civic Engagement & Experiential Learning: Address systemic barriers through civic engagement, including mental and physical health initiatives.
- They currently have about 20 members.
- Funding Request: \$1,000 for shirts this semester; \$5,000 for next semester.
